This deed, made this 25 day of March, 2020, by Christopher L. Mewborn, Commissioner, to Onslow County.

WITNESSETH

That whereas Christopher L. Mewborn was appointed commissioner under an order of the District Court of Onslow County, North Carolina, in the tax foreclosure proceeding entitled "ONSLOW COUNTY vs. HEIRS OF RALPH WHITFIELD, et al" [Court File # 18CVD2337]; and Christopher L. Mewborn was directed by the order as commissioner to sell the property hereinafter described at public sale after due advertisement according to law; and

Whereas Christopher L. Mewborn, commissioner, did on the 22<sup>nd</sup> day of January, 2020, offer the land hereinafter described at a public sale at the Onslow County Courthouse door, in Jacksonville, North Carolina, and Onslow County became the last and highest bidder for the sum of \$4,685.90 and no upset or increased bid having been made within the time allowed by law, and the sale having been confirmed, and Christopher L. Mewborn, commissioner, having been ordered to execute a deed to the purchaser upon payment of the purchase money;

Now, therefore for and in consideration of the premises and the sum of \$4,685.90, receipt of which is hereby acknowledged, Christopher L. Mewborn, commissioner, does, by these presents, hereby bargain, sell, grant, and convey to Onslow County, its successors heirs and assigns, that property situated in Onslow County, North Carolina, and described as follows:

**LYING AND BEING IN THE TOWN OF RICHLANDS, NC BEING A PART OF THE H.W. HUMPHREY LAND AS SURVEYED AND PLOTTED BY J.J. WALTON ON MAY 30<sup>TH</sup>, 1918 AND BEING LOT NO. 2 AS SHOWN ON SAID SURVEY AND DESCRIBED AS FOLLOWS:**

**BEGINNING AT A STAKE ON THE FIELD ROAD AT CORNER OF LOT NO. 1 AND RUNS N 52° 50' W 244 FEET TO A STAKE THE N.W. CORNER OF LOT NO. 1 THENCE S 18-10 W 159 FEET THENCE S 1-10" W 158 FEET TO HOWERTON SANDERS N.E. CORNER THENCE E 219 ½ FEET WITH THE SAID HOWERTON SANDERS'S LINE TO A STAKE, SAID SANDERS'S COURNER, IN LINE OF LOT NO. 3 THENCE WITH LINE OF LOT NO. 3, N 2 EAST 34 FEET TO NEGRO SCHOOL LOT LINE, THENCE N 34-45" E WITH SCHOOL OT LINE 116 FT TO THE STAKE THE BEGINNING. 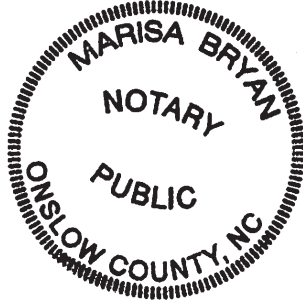
