RULES OF THE ROAD

1. All *Trunk or Treating* vehicles must register and agree to the terms and conditions in the registration form. Only those who have properly registered their vehicles may participate in the event. *You may register for multiple spaces if needed.*
2. Candy is required. You must provide candy for at least 500 youth. Candy must be individually wrapped to participate.
3. Electricity will **not** be available for decorating your vehicle.
4. All vehicles must be parked prior to the event. Trunk staging is from 3-4 p.m. and trunks won't be able leave the area until 8 p.m. *This precaution is to help ensure the safety of all the children wondering the grounds during the evening event.*
5. Registered vehicles will be provided an authorized trunk number upon check in. This number must be placed in a visible location on your trunk.
6. Judging will begin at 6 p.m.
7. **Application deadline October 15.**

TIPS FOR TRUNKIES:

1. **Have something for the parents!**

The kiddos are there for the candy! But what about mom and dad? If you have a coupon for a free sandwich, a business card or post card, a stress ball, etc. then give them to parents. This is the time and place.

2. **Staff your trunk with at least 2 people**

Since all trunks must be manned from 4:30 p.m. till 8 p.m., we encourage you to **staff your trunk with at least 2 people**. This will allow for breaks or long trick or treating lines. Plus, Trunk or Treating is more fun with others.

3. **Stock up on candy early**

Does your trunk require special candy? If so you might want to consider stocking up on that candy early and look out for sales. Candy for 500 youth is required, but if your candy is part of your "thing," then you probably want to stock up with more than the required number of pieces.
