Onslow County Parks & Recreation Department Counselor-In-Training (CIT) Duties & Agreement

Overview:

The summer day camp "CIT" will serve as a volunteer for the Onslow County Parks and Recreation Department and assist the day camp staff in daily supervision of campers. **Volunteers must be entering the 9th grade to be eligible for the CIT program. A letter of recommendation from a teacher, school counselor, or previous supervisor is required.**

General duties and requirements:

- Lead games, sports, crafts, as well as general activities
- Assist in set-up and clean-up of all activities
- Help organize campers in lines, groups, etc. When needed
- Promote a positive relationship with all staff and campers
- Set a good example for campers to follow
- Conduct attendance, pass out lunches
- Assist staff as instructed
- **A letter of recommendation from a teacher, school counselor, or previous supervisor is required.**

No person will be permitted to volunteer unless this form has been completed in full, signed, and submitted to the Onslow County Parks and Recreation Department. A letter of recommendation from a teacher, school counselor, or previous supervisor is required. Applicant must be approved and assigned by the recreation program supervisor.

I understand that the counselor-in-training (CIT) position is a volunteer position and I will receive no salary for work performed. Therefore, I understand that this position is designed for me to gain experience working in a day camp setting. I will obey all camp rules governing the staff, volunteers and campers.
